**MEMORANDUM OF UNDERSTANDING REGARDING MAINTENANCE  
OF COUNTY ROADS THAT ARE BOUNDARY LINES BETWEEN COUNTY  
COMMISSIONERS PRECINCTS**

---

WHEREAS, the Commissioners Court of Johnson County entered Order #2021-88 that sets forth findings of fact regarding political boundaries of Johnson County, Texas following publication of 2020 census data and orders redistricting of political boundaries; and

WHEREAS, the Commissioners Court of Johnson County entered Order #2021-93 that adopts a redistricting plan for the Commissioners Court precincts; and

WHEREAS, precincts 2 and 3 will be reduced in geographical size due to the redistricting plan adopted and will reduce the total miles of county roads in precincts 2 and 3 subject to county maintenance; and

WHEREAS, precincts 1 and 4 will be increased in geographical size due to the redistricting plan adopted and will increase the total miles of county roads in precincts 1 and 4 subject to county maintenance; and

WHEREAS, the Commissioners Court desires to enter into a memorandum of understanding regarding the precinct responsible for county maintenance of a county road that is a boundary line between county commissioners precincts.

IT IS THEREFORE AGREED that the Commissioners Court enter into this Memorandum of Understanding Regarding Maintenance of County Roads That Are Boundary Lines Between County Commissioners Precincts and agree as follows:


1. County roads that are a boundary line between Precinct 1 and Precinct 2 will be maintained by the County Commissioner of Precinct 2.
2. County roads that are a boundary line between Precinct 3 and Precinct 4 will be maintained by the County Commissioner of Precinct 3.
3. County roads that are a boundary line between Precinct 2 and Precinct 4 will be maintained by the County Commissioner of Precinct 2.
4. This Memorandum of Understanding will become effective January 1, 2022.


