ORDER APPROVING DR. KENDALL CROWNS AS THE MEDICAL EXAMINER FOR TARRANT COUNTY, TEXAS

On this the 13<sup>th</sup> day of December, 2021, the Commissioners Court of Johnson County, being duly convened at a regularly called meeting of the Commissioners Court, upon motion of Commissioner White, Pct. #3, seconded by Commissioner Bailey, Pct. #1, duly put and carried, adopted the following:

WHEREAS, Tarrant County, Texas, being an urban county, created a Medical Examiner's Office and appointed a Medical Examiner pursuant to Article 49.25, Sec. 2 of the Texas Code of Criminal Procedure; and

WHEREAS, the Commissioners Courts of Johnson County and Tarrant County have determined that it is in the best interest of the two (2) counties to operate a Medical Examiner's District for such counties; and

WHEREAS, the Commissioners Courts of Johnson County and Tarrant County have maintained a Medical Examiner's District ("District") consisting of the County of Johnson and the County of Tarrant, in accordance with Article 49.25 of the Texas Code of Criminal Procedure; and

WHEREAS, on April 1, 2021, the Medical Examiner, Dr. Nizam Peerwani, notified the Tarrant County Commissioners Court of his intent to retire as Chief Medical Examiner for Tarrant County after 42 years of service; and

WHEREAS, Tarrant County appointed Dr. Kendal Crowns, as Medical Examiner for Tarrant County, effective December 6, 2021, in accordance with Article 49.25, Sec. 2 of the Code of Criminal Procedure to do and perform all duties provided by law for the Office of Medical Examiner.

WHEREAS, Tarrant County has requested the Commissioners Court of Johnson County to approve the appointment of the Tarrant County Medical Examiner as evidenced by Exhibit "A" attached hereto.

NOW THEREFORE BE IT ORDERED, ADJUDGED AND DECREED, that the Commissioners Court of Johnson County, Texas approves the appointment of Dr. Kendall Crowns as the Medical Examiner for Tarrant County, Texas.

#### **COMMISSIONERS COURT ACTION REQUESTED:**

It is requested that the Commissioners Court approve the appointment of Dr. Kendall Crowns as the Medical Examiner for Tarrant County in accordance with Article 49.25 Sec. 2, Code of Criminal Procedure.

#### BACKGROUND:

On April 1, 2021 Dr. Nizam Peerwani notified the Commissioners Court of his intent to retire as Chief Medical Examiner for Tarrant County after 42 years of service.

On June 1, 2021, the Commissioners Court approved an agreement to retain Hartz Search to conduct a search for Tarrant County's next Chief Medical Examiner.
