Construction costs are expenses incurred for labor, material, equipment, and services associated with structural and land management implementation. Such costs include, but are not limited to, direct costs associated with items such as earthwork removal or replacement, purchase and installation of materials and appurtenances, and construction inspection.

Oversight costs are expenses incurred to monitor construction.


