COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE DENTAL SERVICES PROVIDED BY DR. RICHARD LANCE BULLARD, D.D.S. d.b.a. COUNTYWIDE DENTAL ARE PROFESSIONAL SERVICES

The Johnson County Commissioners Court met on January 24, 2022 in regular session for the consideration of a contract between Johnson County, Texas and Dr. Richard Lance Bullard, D.D.S. d.b.a. Countywide Dental, the Commissioners Court finds that this contract is for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Woolley, Pct. #4 seconded by Commissioner \_\_White, Pct. #3 that: "The Commissioners Court find the contract for dental services provided by Dr. Richard Lance Bullard, D.D.S. d.b.a. Countywide Dental is a contract for professional services and that the Commissioners Court grants an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an order to that affect, and that the Commissioners Court approve the contract for dental services with Dr. Richard Lance Bullard, D.D.S. d.b.a. Countywide Dental."

The Commissioners Court of Johnson County, Texas does hereby enter this order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that the contract for dental services with Dr. Richard Lance Bullard, D.D.S. d.b.a. Countywide Dental, is a contract for professional services.
