PROCLAMATION

CHILD ABUSE PREVENTION MONTH

WHEREAS, In 2021 there were 262,420 alleged child abuse victims in the state of Texas. There were 1,997 Intake Reports in Johnson County, 820 investigations currently open and 1,177 abuse or neglect completed investigations, there were 207 confirmed victims. Further, there were 158 children in conservatorship with CPS in 2021; and

WHEREAS, Child abuse prevention is a community responsibility and finding solutions depends on involvement among all people; and

WHEREAS, Effective child abuse prevention and service programs in Johnson County succeed because of partnerships among a variety of entities including but not limited to, schools, religious organizations, law enforcement agencies, child protective services, child welfare boards, rainbow rooms, prosecution agencies, medical professionals, mental health professionals, children's advocacy centers, crisis centers, CASA programs, and other community-based non-profit organizations; and

WHEREAS, Everyone in the community should be aware of the prevalence of child abuse and neglect, and understand that there are prevention programs available to help teach parents to raise their children in safe, nurturing environments as well as supporting local professionals dedicated to meeting the needs of child abuse victims;

NOW THEREFORE, BE IT RESOLVED THAT I, Roger Harmon, County Judge of Johnson County, and we the Commissioners of the four Precincts in Johnson County, Texas, do hereby proclaim the month of April, 2022, as:


“CHILD ABUSE PREVENTION MONTH”






