Project Description - Next Step provides care to those with unexpected pregnanices. We believe in holistic support. We provide free parenting help, classes, and ongoing support during and after pregnancy. Since Covid, the need for services has risen dramatically. Individual clients increased 100% with a client visit increase of 231% (1.782 in 2019 - 5.892 in 2021). The number of clients taking prenatal and parenting classes increased 317%. Due to the need in Johnson County we have provided an increase of material assistance to our residents, including baby items, furniture and clothing. In 2021, alone, we distributed 137.015 diapers. With the growing needs of our community our need to expand our services, offering OB/Gyn, prenatal care and STI/STD testing. The new building will also house a new free medical clinic which will offer care for those uninsured entitled Caring Physicians Charity Network (CPCN) clinic.

Project Location - Currently in negotiations for land in Burleson.

Project Budget - \$2,715,400.00 (\$200.00 per square foot)

**Project Timeframe -** It will take approximately 3 months to start the project getting all plans drawn up; an approximate of 30 - 60 days for permitting: 6 to 7 months for building.







## Projected Staffing and Reach in New Facility

- ▶ In our current facility we have the availability to serve 18 clients per day.
- ▶ In the new facility we will have the potential to serve up to 60 clients per day.
- In the new facility we would employ at least 6 new staff members.

#### **CPCN Burleson Medical Clinic**

- Our goal is to serve the uninsured, underinsured and the underserved members of our community.
- Our goal is to have 500 to 1,000 patient visits in our first year of operation, increasing to 2,000 in year three and 5,000 by year five.
- ➤ Our research shows that an estimated \$176 billion in health care costs are incurred by the uninsured or underinsured. With our facility we are estimating to save the "systems" 1 million dollars in the first year.
