#### Project Description-

Children deserve to feel safe. Unfortunately, that is often not the case evidenced by rampant school violence. Campus Crime Stoppers gives a child a safe avenue to alert officials of disturbing behavior, remain anonymous, and receive a reward.


**Project Location-** The video will be shown at secondary schools throughout Johnson County, TX. The video will also be available to other venues serving teenagers.


## **Estimate Assumptions**

### School Shootings in the United States Since 2000-2001

The K-12 School Shooting Database shows that Texas has had the 2nd highest number of shootings since 1970 with 133 just behind California with 158.
