BE IT KNOWN that on the 26th day of April 2022, the Honorable Commissioners Court of Johnson County, Texas, met in Special Session at the Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:03 A.M. (County Judge, Roger Harmon stated the time as 9:00 A.M.) with all members present the following items, having been lawfully posted and filed for record in the office of the County Clerk on April 22, 2022 at 1:03 P.M. were considered:

II. PRECEEDING BUSINESS

1. CONSIDERATION OF ELIMINATING TWO PART-TIME TEACHER POSITIONS AND ADDING ONE FULL-TIME TEACHER POSITION TO JUVENILE JUSTICE ALTERNATIVE EDUCATION PROGRAM (JJAEP)-JUVENILE SERVICES

Comm. Woolley, seconded by Comm. White, made a motion to approve Eliminating Two Part-Time Teacher Positions and Adding One Full-Time Teacher Position to Juvenile Justice Alternative Education Program (JJAEP) by adopting the plan as presented, effective August 1, 2022, and to fund the positions with ARPA Funding for the duration of the ARPA Program-Juvenile Services.

Comm. Woolley withdrew his motion.

Comm. Woolley, seconded by Comm. White, made a motion to approve to add two full-time teacher positions and to fund only those two positions with ARPA Funding for the duration of the APRA Program, effective August 1, 2022.

All voted aye; motion carried.



Comm. White, seconded by Comm. Woolley, made a motion to approve the Lease Agreement Between Johnson County and Cleburne ISD for the Building Located at 1005 S. Anglin, Cleburne, Texas 76033 and to give County Judge, Roger Harmon the authorization to sign-Juvenile Services.

All voted aye; motion carried.
