The JJAEP teaching staff currently consists of 1 F/T Teacher and 1 P/T Teacher.

One additional P/T Teacher was approved by the court on January 24, 2022. This was intended to help us get through the remainder of the current school year. This position has not been filled.

On February 28, 2022, the court approved another 1 F/T Teacher and 2 P/T Teachers to start on August 1 for next school year. This would have put my teaching staff at a total of 2 F/T and 4 P/T teachers. (See yellow box.)

I've only had 1 applicant for a P/T position and the individual was not qualified. I've had several well qualified applicants for the F/T position. Therefore, I would like to ask the court to approve one more F/T Teacher in place of 2 P/T positions. My plan would be to operate with 3 F/T and 1 P/T teachers and leave 1 P/T position open to be filled as needed based on our growth. (See blue box.)
