BE IT KNOWN that on the 16th day of May 2022, the Honorable Commissioners Court of Johnson County, Texas, met in Special Session at the Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:01 A.M. with all members present the following items, having been lawfully posted and filed for record in the office of the County Clerk on May 12, 2022 at 1:03 P.M. were considered:

I. <u>CALL TO ORDER</u>

County Judge, Roger Harmon opened the Meeting with a word of prayer.

II. <u>NEW BUSINESS</u>

1. <u>CONSIDERATION OF THE CANVASSING FOR THE MAY 7, 2022</u> CONSTITUTIONAL AMENDMENT ELECTION-ELECTIONS OFFICE

Comm. Woolley, seconded by Comm. White, made a motion to approve the Canvassing for the May 7, 2022 Constitutional Amendment Election with the voter total being 5,412 as presented-Elections Office.

County Judge, Roger Harmon commented to ask Kevin Dyer with GrantWorks for clarification on the procedure for any unspent funds left over from the granted amounts.

Kevin Dryer commented that if the funds were distributed on a reimbursement basis, the funds not used would simply never leave the County's "pocket". Whereas, if the funds were distributed as an up-front lump sum, any unexpended funds would be returned to the County and would be subject to the same restrictions as the original ARPA funds. Kevin Dryer also noted that if enough funds were unexpended and/or unexpended and returned, and the funds were initially counted as coming out of the County's potential lost revenue, then the ARPA funds could be spent up to the lost revenue amount.
