It is our goal to replace our 40+ year old wastewater treatment package plant.

The expected life span of a package plant of this kind is about 30 years. To effectively continue to produce not only a safe but decidedly beneficial final discharge into Lake Alvarado a new plant must be acquired soon.

The new plant will be fabricated at a facility in town and then assembled on a concrete slab at our existing treatment plant. It will nearly be a plug-and-play operation as the existing inlet and out flow will be used.

The requested funds will be used to replace the existing plant and ensure the treatment plant is compliant with TCEQ requirements.

Needed to complete project: Site Survey, Plant Fabrication, foundation work, installation, power backup installation.

Project Location - Where your project will be performed, such as "500 feet along Main Street". Include maps, if available.

At our existing treatment plant at: 362 Tranquil Lane, Alvarado, TX 76009



Thank you Commissioners Wooley and Bailey for your feedback already.

I had a wonderful 30 minute phone call this morning with Mr. Firoj Vahora, Team Leader -- Municipal Permits Team (MC 148) Wastewater Permitting Section, Water Quality Division, TCEQ. He wants to do everything he can on the regulatory side of things to help us make this happen. Some things came to light as he was looking into our particular situation.

- 1) Per TCEQ we do not need a new permit to install a new treatment plant for maintenance reasons. This includes installing a treatment plant that has a greater capacity than what we are permitted to discharge. (that is really good news)
- 2) The current placement of our WWTP is in violation of our permit that dictates we will follow the TCEQ rules for property easements. The required buffer for a WWTP to the property boundary is 150 ft and ours is more like 25 ft on the south and west sides that boarder farmers' fields. Why this has been an oversite with the regional TCEQ office for the last 50 years he was unable to say. (that is really bad, but not unfixable)
- 3) I have already called farmer Kevin Moore this morning to ask that he entertain the idea of selling us a portion of the property he owns to the west of the treatment plant so we can completely operate in compliance. He said his answer isn't "no", but that the property is in some kind of probate, and he should have it in his name in the next couple of months. (This could be really good)


All in all I believe having all these things come to light is a tremendous blessing. Establishing proper easements will make the surrounding farmland more inhabitable and valuable. Very few people would be excited with having a treatment plant a few feet from their back door.

If we get this right, I can see this treatment plant being a valuable assent to the county for many years to come, without being encumbered with technical flaws.

I am attaching a graphic I put together using Google Earth and Photoshop to illustrate what the new treatment plant property boundaries might look like as well as our current site drawing. According to Google Earth the additional area to provide sufficient space is 2.9 acres.

Commissioner Bailey requested that I pursue the idea of installing a larger wastewater treatment plant than what we currently have to facilitate a new permit in the future.

I have yet to hear back from my TCEQ contacts, but I have spoken with Cleve Weyenberg Jr at Texas Tech Environmental who fabricates package plants. His recommendation is that to double the treatment plant capacity, from 30K gal/day to 60K gal/day would require a budget of \$1.4 million. I have requested \$0.75 million so it would be less than double what I have requested, but still significantly more money.

I am going to pester TCEQ again today to see if I can get some responses back. The concerns I have is that currently there is a required distance buffer of 150 feet from the treatment plant to the property lines. Ours was not built with this current specification. If we build a larger facility we may no longer qualify for being "grandfathered in." If indeed we do need to ensure 150 feet distance to our fence lines, we could potentially need to acquire more land, up to 3 acres.

TO THE HONORABLE JUDGE ROGER HARMON,

I am a resident and owner of (2) properties in Blue Water Oaks. The residence where I reside is 164 Chambers Drive, Alvarado, Tx. 76009, located right next door to the Blue Water Oaks boat ramp.

My other property is located at <u>288 Chambers Drive</u>, <u>Alvarado</u>, <u>Tx. 76009</u>, and is one lot over from the Orange Discharge Line for, "Final Effluent," into Alvarado Lake.

David Preisner has been telling the Property Owners of BWO for years that everything with the Water and Sewer Treatment Plant were good, Which come to find out yesterday, was not true. The truth of the matter is that BWO Sewer Service & Water Supply corporation, has been operating illegally for years, according to David Preisner, yesterday at the Board Meeting.

According to the U.S. Department of Treasury regarding the Coronavirus State and Local Fiscal Recovery Funds, Compliance and Reporting Guidance, Part 1C., Treasury's Final Rule, 2.d., Investments in Water, Sewer, and Broadband....,"Recipients may use SLFRF award funds to cover costs incurred for eligible projects planned or started prior to March 3, 2021, provided that the project costs covered by the SLFRF award funds were incurred by the recipient after March3, 2021."

The Blue Water Oaks Meeting Minutes for February 10, 2021, cite, David Preisner, stating for the Water & Sewer Report that, "EVERYTHING RUNNING AS EXPECTED." AND, for March 10, 2021, Water & Sewer Report that, "DAMAGES SUSTAINED AT WELL SITES, DUE TO WEATHER, ARE ALL REPAIRED. INQUIRING ON POND CERTIFICATION THRU TCEQ. POSSIBLE HEAT STRIPSAND GENERATOR FOR FUTURE WEATHER ISSUES AT WELL SITES."

THE BLUE WATER Oaks general meeting minutes of April 14, 2021, Water & Sewer Report state, "WASTE WATER POND NO CERTIFICATION, CLOSE POND. FINISH APPLYING FOR A PERMIT. DISCUSSIONS ON REPLACING TREATMENT PLANT TO COST AROUND (\$500,000-\$650,000) TO REPLACE. NORMAL LIFE SPAN IS 30 YEARS ON TREATMENT PLANT. NEED ESTIMATE ON FRAC TANK FOR SEWER ISSUES AROUND CREEK AND DUMPSTERS. ALSO NEED AN ESTIMATE ON MACHINERY FOR THAT FIX."

It is evident that Blue Water Oaks does not meet the first requirement to receive SLFRF award funds as they did not begin talking about replacing the Water & Sewer Treatment Plant until after being denied certification of the wastewater treatment pond sometime between March 10, 2021 and April 14, 2021.

For 2 ½ years, I and other have been demanding a forensic accounting of the Books or Blue Water Oaks Property Owners Association and BWO Sewer Service & Water Supply Corporation. There has been a long list of Misappropriation of Funds that has been covered up due to the fact that David Preisner's wife, Tasha Preisner is doing the books for both entities, and for the Volunteer fire Department, that

David Preisner is also the Director of. Our Former Secretary, Karen Stutzman, stole thousands of dollars, and the Board refuses to give a proper accounting.

As a result, I have had threats against my life, physically assaulted by a Board Member's husband who struct me from behind, while I was sitting on a motorcycle. This same individual pulled a gun out on 6 of us at my house and asked, "who wants to get shot first?" Id. Johnson County Sheriff's Case #21-00002951; 2021-130192; 21-00003024.

We have an out of control Board, that rigs elections, practices, "Selective Enforcement," against Property Owners that they don't like, all the while they and/or their friends never receive Assessments or, "Special assessments," as they call them, so they can put a Lien against that Property Owner's Property.

They created Blue Water Oaks Water and Sewer LLC, illegally with the Secretary of State, as our Founding Documents require us to be a Non-Profit entities. This LLC, was created December 3, 2021, for the sole purpose to receive these SLFRF Funds, enable them to pay themselves, and funnel money as needed for the Water and Sewer Treatment Plant, which they are expecting to cost around, \$500,000, not the \$750,000 they have requested.

We have approximately, 18 families who are looking to file suit against the Board for their violations of our Founding documents. We have brought this to several Lawyers, but Mr. Conover, declined, and so did Mr. Ridgley, and a couple others from Ft. Worth. Our problem is getting together the \$10,000, its going to cost for a Lawyer who specializes in suits against POA's.

The facts are that due to years of Malfeasance, by Board Members, Water & Sewer Treatment Plant individuals, and the Maintenance Department, our Water and Sewer Treatment Plant is in the shape it is in. BWO Property Owner's Association and BWOPOA Sewer Service & Water Supply Corporation, should be disbanded and absorbed into the County.

Therefore, for all the aforementioned, I pray that you would DENY, Blue Water Oaks, the SLFRF funds they have requested, as they DO NOT QUALIFY.
