This project is for the expansion of the City of Rio Vista's Wastewater Treatment Plant (WWTP). The current plant has a rated capacity of 0.1 Million-Gallons per Day (MGD) Average Annual Daily Flow (AADF). In 2018, the plant experienced an AADF of approximately 0.106 MGD, or 106% of rated capacity. Since then, the city has made improvements to their wastewater collection system resulting in a reduction of flow to 0.076 MGD, or 76% of rated flow. The Texas Commission on Environmental Quality (TCEQ) requires that when a treatment facility reaches 75% of rated capacity, improvements must be designed to increase the total capacity. It is recommended that the City not add any new connections until this issue is resolved. A preliminary conceptual level design report for this project has been completed. Based on the results of the report, the city has decided to expand their plant to an AADF of 0.3 MGD thus allowing them to add up to 800 residential connections. The expansion of the plant will require at a minimum a new headworks screening facility, new secondary treatment basins and equipment, a new chlorine contact basin, and various Site, Electrical, and Instrumentation Improvements.

The Rio Vista WWTP is located 2400-feet South and 4000-feet East of the intersection of 916 & SH 174 in Rio Vista, TX 76093.
