Bailey, Pct. #1 and the following items, having been lawfully posted and filed for record in the office of the County Clerk on July 1, 2022 at 3:24 P.M. were considered:

1. CONSIDERATION TO CONSENT TO THE RENEWAL OF THE
DECLARATION OF DISASTER FOR JOHNSON COUNTY FILED ON JUNE
29, 2022 THAT INCLUDED A BAN ON FIREWORKS, AS EXTENDED BY
THE GOVERNOR OF TEXAS-COUNTY JUDGE'S OFFICE

Comm. White, seconded by Comm. Woolley, made a motion to approve the Declaration of local Disaster due to the threat of wildfire, that was issued pursuant to Texas Government Code Section 418.108 by the Johnson County Judge on June 19, 2022 at 10:32 A.M. that Included a Ban on the use of Fireworks that was Extended by the Governor of the State of Texas until such time as conditions warranting restrictions are ameliorated including a determination from the Texas A&M Forest Service (TAMFS) that the Keetch-Byram Drought Index (KBDI) has dropped to an intensity less than 575 be extended and continue in effect until terminated by the County Judge-County Judge's Office.

Comm. White amended his motion changing the date of June 19, 2022 to June 29, 2022, Comm. Woolley stated his second still stands.

Comm. Woolley asked if there would be a definite termination date, or would it be based off the drought index.

Assistant County Attorney, Jim Simpson replied it would be based on the drought index and would need a termination by the County Judge.

Additional discussion between the Court, Tom Foster, Executive Director of Johnson County ESD No. 1 and Jamie Moore, Johnson County Emergency Management Coordinator.

All voted aye; motion carried.

County Judge, Roger Harmon commented for Court Record that Comm. Bailey, Pct. #1 was absent from today's Meeting.
