Comm. White stepped out of the Meeting at 10:54 A.M. and returned at 10:55 A.M.

The Commissioners Court reconvened into Regular Session at 11:27 A.M. to consider the following:

2. <u>CONSIDERATION OF PROPOSALS AND PROJECTS FOR THE AMERICAN</u> RESCUE PLAN ACT (ARPA) FUNDING

Comm. Bailey, seconded by Comm. White, made a motion to approve to include all ESD and Volunteer Fire Departments at an additional cost of \$130,000.000 per year.

Comm. Bailey, seconded by Comm. White, amended his motion to note that the additional cost of \$130,000.00 per year to include all ESD and Volunteer Fire Departments was an additional cost to the previously approved software package.

All voted aye; motion carried.

Comm. Bailey, seconded by Comm. Howell, made a motion to approve to allow Facilities Management to make an emergency purchase of a local 2021 Box Truck at a cost \$69,950.00 using APRA Funds.

There was a question about if the truck would be purchased with ARPA Funds or through

Lost Revenue.

All voted aye; motion carried.

Comm. Bailey, seconded by Comm. Howell, made a motion to approve to amended the previously approved amount of \$30,000.00 of the 2.4 million set aside for a generator for the Guinn Justice Center to increase to \$55,000.00 to cover the cost of a repeater system.

No vote taken.

The Court returned to the discussion of the funding for the Box Truck.

Comm. Bailey, seconded by Comm. Howell, amended his previous

motion to allow Facilities Management to make an emergency purchase of a local 2021 Box

Truck at a cost \$69,950.00 but with funds to come from Lost Revenue.

Judge Harmon called for a vote but before the vote was cast, Comm. Woolley

commented that the Court could not do that because they had already voted on that item.

County Attorney, Bill Moore asked for clarification in regards to the amended amount for

the repeater system.

Judge Harmon called for a vote in regards to the motion and second for the amended

amount for the repeater system.

Comm. Woolley commented that the best course of action would be for the motion and

second to be withdrawn.

Comm. Bailey withdrew his motion and Comm. Howell withdrew his second.

Judge Harmon called for a vote in regards to the motion and second for the amended

motion to allow Facilities Management to make an emergency purchase of a local 2021 Box

Truck at a cost \$69,950.00 but with funds to come from Lost Revenue.

All voted aye; motion carried.

There being no further business before the Court concerning this agenda, the

Commissioners Court adjourned at 11:51 A.M.
