The meeting was called to order at 9:05 A.M. with all members present and the following items, having been lawfully posted and filed for record in the office of the County Clerk on July 14, 2022 at 1:12 P.M. were considered:

County Judge, Roger Harmon opened the Meeting with a word of prayer and thanked everyone for coming.

Comm. Bailey made a motion to approve the purchase of 10 Dodge Chargers for Sheriff, Adam King using next year's budget.

After additional discussion and the recommendation of the County Auditor and Judge Harmon, Comm. Bailey withdrew his motion and the Court agreed to add this item to Monday's Agenda.

There being no further business before the Court concerning this agenda, Commissioners Court adjourned at 4:27 P.M.
