COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE DENTAL SERVICES PROVIDED BY DENTRUST DENTAL TEXAS, P.C. ARE PROFESSIONAL SERVICES

The Johnson County Commissioners Court met on July 25, 2022 in regular session for the consideration of a contract between Johnson County, Texas and DENTRUST DENTAL TEXAS, P.C. the Commissioners Court finds that this contract is for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Howell, Pct. #2, and seconded by Commissioner Woolley, Pct. #4, that: "The Commissioners Court find the contract for dental services provided by DENTRUST DENTAL TEXAS, P.C. is a contract for professional services and that the Commissioners Court grants an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an Order to that affect, and that the Commissioners Court approve the contract for dental services with DENTRUST DENTAL TEXAS, P.C."

Said motion was approved by a vote of the Commissioners Court on the 25th day of July, 2022.

The Commissioners Court of Johnson County, Texas does hereby enter this Order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that the contract for dental services with **DENTRUST DENTAL TEXAS**, **P.C.**, is a contract for professional services.
