



**A RESOLUTION BY THE COMMISSIONERS COURT OF JOHNSON COUNTY  
AUTHORIZING THE JOHNSON COUNTY SHERIFF’S OFFICE TO FORM  
A REGIONAL LAW ENFORCEMENT MUTUAL AID TASK FORCE  
AGREEMENT WITH OTHER AREA LAW ENFORCEMENT  
AGENCIES FOR THE PURPOSE OF PROVIDING AND  
RECEIVING LAW ENFORCEMENT ASSISTANCE**

**WHEREAS**, the County of Johnson desires to contribute to the protection and safety of citizens in this City and in surrounding communities; and

**WHEREAS**, the legislature has authorized the formation of Interlocal Assistance Agreements between and among the cities and their law enforcement agencies; and

**WHEREAS**, the County of Johnson wishes to participate in an Interlocal Assistance Agreement among local law enforcement agencies in the greater Dallas-Fort Worth, North Texas area for the purpose of providing and receiving law enforcement assistance; and

**WHEREAS**, the Johnson County Sheriff’s Office and other local law enforcement agencies have tentatively approved an Interlocal Assistance Agreement to be known as the Greater Dallas-Fort Worth Regional Law Enforcement Mutual Aid Task Force Agreement; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF JOHNSON COUNTY THAT:**

SECTION 1: The Johnson County Judge is hereby authorized to execute the attached “Greater Dallas-Fort Worth Regional Law Enforcement Mutual Aid Task Force Agreement.”

SECTION 2: This Resolution shall take effect immediately from and after its approval by the Commissioners Court and signing by the County Judge of Johnson County and it is accordingly so resolved.




