A RESOLUTION BY THE COMMISSIONERS COURT OF JOHNSON COUNTY AUTHORIZING THE JOHNSON COUNTY SHERIFF'S OFFICE TO FORM A REGIONAL LAW ENFORCEMENT MUTUAL AID TASK FORCE AGREEMENT WITH OTHER AREA LAW ENFORCEMENT AGENCIES FOR THE PURPOSE OF PROVIDING AND RECEIVING LAW ENFORCEMENT ASSISTANCE
