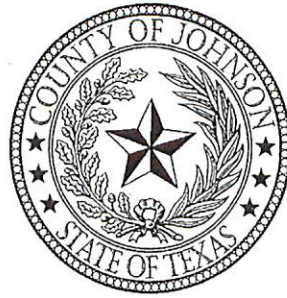

**NOTICE OF PUBLIC HEARING ON**  
**PROPOSED JOHNSON COUNTY**  
**BUDGET FOR 2022-2023**

On Tuesday, September 6, 2022 at 9:00 am at the Johnson County Courthouse, #2 North Main St., Rm. 201, Cleburne, Texas 76033, the Johnson County Commissioners Court will conduct a public hearing for the purpose of receiving public comment on the following issue:

“Proposed County Budget for 2022-2023”

This budget will raise more revenue from property taxes than last year’s budget by an amount of \$8,910,511.00 which is a 15.18 percent increase from last year’s budget. The property tax revenue to be raised from new property added to the tax roll this year is \$3,308,963.00.

After said public hearing, The Commissioners Court will consider the adoption of the Proposed County Budget for 2022-2023.




