Johnson County will provide exhibit stickers for all Deputy Official Court Reporters. Deputy Official Court Reporters will provide their own computer disks.

Johnson County will pay mileage for Deputy Official Court Reporters in the amount set by the Commissioners Court for Johnson County employees per County Policy.

INDIGENT CRIMINAL APPEALS

Official Court Reporters and Deputy Official Court Reporters shall be paid \$5.50 per page for an original and two copies on all indigent criminal appeals. Copies of exhibits will be compensated for at the rate of .60 cents per page. The cost of binders and binding, as well as deliveries, will be included in the above per page rates. All postage costs will be reimbursed to the Court Reporters in all indigent appeals.
