Woolley, made a motion that the property tax rate be increased by the adoption of a tax rate of \$0.415000, which is effectively a 10.55 percent increase in the tax rate and to approve Order Number 2022-71 which sets forth the property tax rate for Johnson County at \$0.415000 per \$100 assessed valuation for the 2022 tax year and sets the General Fund M & O Tax Rate at \$0.361000 per \$100 assessed valuation, the Debt Service Tax Rate at \$0.007455 per \$100 assessed valuation, and the FMLR M & O Tax Rate at \$0.046545 per \$100 assessed valuation; as read from **Order #2022-71**.

Comm. Woolley commented that the half a cent the Judge was referring to was shifted over from the M & O Rate to the FMLR M & O, raising that rate from .041545 to 0.046545, to support the Road and Bridge Tax Rate which, the Court agreed, was at a non-sustainable level.
