Johnson County, Texas is donating this Property to the City of Grandview pursuant to Subsection 272.001 (l) of the Local Government Code for a purpose that benefits the public interest of the City of Grandview as said Property is adjacent to property owned by the City of Grandview wherein the City's water well is located and said property will be used by the City of Grandview for public use and/or the public purpose of Public Works Operations, which is carrying out a purpose that benefits the public interest of the City of Grandview, the donation of the property is made under terms that effect and maintain the public purpose for which the donation is made, and the title and right of possession of the property will revert to Johnson County, Texas if the City of Grandview ceases to use the land in carrying out the public purpose.

Property (including any improvements):

Pursuant to Subsection 272.001 (l) of the Local Government Code, the title and right to possession of the property will revert to Johnson County, Texas if the City of Grandview ceases to use the property in carrying out the public purpose.

Grantor, for the consideration and subject to the reservations from and exceptions to conveyance and warranty, grants, sells, and conveys to Grantee the property, together with all and singular the rights and appurtenances thereto in any wise belonging, to have and hold it to Grantee, Grantee's heirs, executors, administrators, successors, or assigns forever. Grantor binds Grantor and Grantor's heirs, executors, administrators, and successors to warrant and forever defend all and singular the property to Grantee and Grantee's heirs, executors, administrators, successors, and assigns against every person whomsoever lawfully claiming or to claim the same or any part thereof, except as to the reservations from and exceptions to conveyance and warranty, when the claim is by, through, or under Grantor but not otherwise.

When the context requires, singular nouns and pronouns include the plural.

CITY OF GRANDVIEW RESOLUTION NO. 2022-0915A

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GRANDVIEW, TEXAS, ACCEPTING THE DONATION OF CERTAIN REAL PROPERTY FROM JOHNSON COUNTY, TEXAS; DESIGNATING THE REAL PROPERTY TO BE USED FOR PUBLIC USE AND/OR THE PUBLIC PURPOSE OF PUBLIC WORKS OPERATIONS.

WHEREAS, under §272.00(1) a political subdivision of the state may donate or sell for less than fair market value a designated parcel of land or an interest in real property to another political subdivision if (1) the land or interest will be used by the political subdivision to which it is donated or sold in carrying out a purpose that benefits the public interest of the donating or selling political subdivision; (2) the donation of the land or interest is made under terms that effect and maintain the purpose for which the donation or sale is made; and (3) the title and right to possession of the land or interest revert to the donating or selling political subdivision if the acquiring political subdivision ceases to use the land or interest in carrying out the public purpose; and

WHEREAS, Johnson County, Texas, is willing to donate, Lot 1A, Block 12, a tract of real property ("the Property"), to the City of Grandview, the Property being fully described in the attached Exhibit A; and

WHEREAS, the City of Grandview intends to utilize the Property for the public purpose of Public Use and/or public purpose of Public Works Operations; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRANDVIEW, TEXAS, THAT:

SECTION 1

The above recitals are true and correct and are incorporated by reference into this resolution.

SECTION 2.

The City Council hereby accepts the donation of the Property from Johnson County, Texas.

SECTION 3.

The City Council hereby designates the Property to be utilized for public use and/or the public purpose of Public Works Operations.

SECTION 4.

This resolution shall become effective immediately upon its passage and it is so ordained.
