**Amendment and Extension of Interlocal Cooperation Agreement for
Secure Short-Term Detention Services
(between Johnson County and Hill County)**

Whereas, the parties hereto previously entered an Agreement whereby Johnson County agreed to provide to Hill County access to space for short-term secure detention care for children of juvenile age with Rite of Passage Inc. (hereafter referred to as "ROP") at the ROP facility named Lake Granbury Youth Services, located at 1300 Crossland Road, Granbury, Hood County, Texas. Said secure detention services to be provided with the consent of ROP and pursuant to an Agreement between Johnson County and ROP.

Whereas, the parties to this Agreement desire to extend the term of the Agreement (executed by Johnson County Judge Roger Harmon on October 25, 2021 and Hill County Judge Justin Lewis on September 28, 2021) as set out in Section 1 of the Agreement but also desire to amend the compensation to be paid to Johnson County by Hill County as set out in Section 3 of said Agreement.

Therefore, the parties agree that daily rate for the contract which was \$155.00 per day will, beginning on **September 1, 2022**, be \$220.00 per day, all other provisions shall continue as set forth in the Agreement between the parties (executed by Johnson County Judge Roger Harmon on October 25, 2021 and Hill County Judge Justin Lewis on September 28, 2021).

This Amendment shall be effective upon the date of the last signature of the signers set out below.






