



## SUMMARY OF THIS NOTICE

### **Opioid Abatement Trust Fund Settlement Payments - Request for Verification of Contact Information**

As part of Senate Bill 1827 passed by the Texas Legislature in 2021, the Opioid Abatement Trust Fund (“the Trust Fund”) was established to receive opioid abatement litigation settlement proceeds and to make distributions to Trust Fund recipients. The Trust Fund is made up of payments received by the state from settlements against opioid manufacturers, distributors, and other parties subject to a civil action for an opioid-related harm associated with the marketing, promotion, distribution, dispensation, or sale of opioids. Under Government Code § 403.506(c)(1), 15% of opioid funds received by the state will be distributed to the Subdivisions (consisting of counties and cities) to address opioid-related harms and in accordance with the guidance provided by the 87<sup>th</sup> Legislature General Appropriations Act and Exhibit B of the Global Settlement Allocation Term Sheet dated May 13, 2020: <https://comptroller.texas.gov/programs/opioid-council/docs/texas-settlement-allocation-term-sheet.pdf>

### **Who is Requesting Verification of Contact Information?**

The Texas Treasury Safekeeping Trust Company (the “Trust Company”) will manage, hold, and invest the Trust Fund. It is also responsible for distributing money allocated to the fund in accordance with the law. The Trust Company was created by the Legislature as a special purpose entity to efficiently and economically manage, invest and safeguard funds for its clients: The State of Texas and its various subdivisions. ### **Action Required**

This notice is being sent to you because your Subdivision has been identified as one entitled to a portion of the settlement proceeds and you have been identified as a contact person for the Subdivision. To keep you and your Subdivision informed regarding the settlements, it is critical that the Trust Company verify the contact information for the following representatives of your Subdivision: 1) Executive Director, City Manager, Chief Executive Officer, or Other Administrative Head and 2) Director of Finance, Chief Financial Officer, or other Head of Financial Operations.
