ORDER AUTHORIZING FIREWORKS SALES

WHEREAS, the Commissioners Court of Johnson County is authorized under Occupations Code Section 2154.202(h), to issue an order allowing retail fireworks permit holders to sell fireworks to the public in celebration on certain holidays; and

WHEREAS, on the 13th day of February, 2023, the Commissioners Court of Johnson County has determined that conditions are favorable to issue such an Order.

NOW, THEREFORE, the Commissioners Court of Johnson County adopts this Order authorizing the sale of fireworks to the public by retail fireworks permit holders during:

1. Texas Independence Day period beginning February 25, 2023 and ending at midnight March 2, 2023
2. San Jacinto Day period beginning April 16, 2023 and ending at midnight on April 21, 2023
3. Memorial Day period beginning May 24, 2023 and ending at midnight on May 29, 2023
