#### WELCOME VISITORS, ANNOUNCEMENTS & PRESENTATIONS

1. Announcements from County Commissioners, Elected Officials, and Department Heads

Comm Bailey announced that the Legislature's session had started with the introduction of over 3,000 bills that will affect local county government. He commented that the legislative team would meet to go over what had been presented.

Comm. Woolley announced that the Johnson County Livestock Show success, although final numbers on sales had not yet been conrifmed. Further commenting, he stated Johnson County students were already competeing in the Fort Worth Stock Show. Comm. Woolley recognized Mason Grady from Grandview who had Reserve Champion Steer at the National Western Stock Show in Denver, as well as in the show in Oklahoma City, and who also had Grand Champion and Reserve Champion Steer at the County Show. Comm.

Woolley continued with well wishes to the 4-H and FFA participants as they compete in different shows in the next couple of months.

2. Presentation of Proclamation Jack Rowland Day

Comm. Woolley read the Proclamation for Jack Rowland Day for Court Record, and then he, along with the other Members of the Commissioners Court, presented the Proclamation to Jack Rowland.
