Mayor, Jacob Wheat, City Manager, Paul DeBuff and City Attorney, Ashley Dierker addressed the Court. Also present for the City of Alvarado were Interim City Engineer, Ram Ramachandra and Planning Director, Justin French.

County Judge, Christopher Boedeker opened the discussion up to the Court.

Comm. Howell, for clarification, asked if this was for platting only and how would septic issues be taken care of if there are any.

Public Works Director, Jennifer VanderLann answered that this was only for platting for manufactured home rental communities, and if the project changes, it will be looked at differently. She added, all permitting authority still lies with the County.
