

Erick Whitlock – North Richland Hills Police Department Tenacity-Technology-Teamwork

The Tenacity-Technology-Teamwork led by Detective Erick Whitlock led to the charging and long fall of a suspect in a 19-year-old cold case involving the shooting of Motorcycle Officer Jeff Garner and a string of Bank Robberies.

The intricate investigation involved North Richland Hills Police, Oklahoma State Bureau of Investigation (OSBI), and the Federal Bureau of Investigation (FBI) Dallas and Oklahoma City field offices. Officer Jeff Garner was shot on March 3, 2003, after attempting to stop a man who, unknown to Garner, had just robbed a bank in Watauga, Texas. Since the incident, the suspect has remained at large. After the case sat cold for many years, in 2015, North Richland Hills Police Detective Erik Whitlock was assigned to the investigation. He began examining the evidence related to the incident. Based on the analysis, the suspect in the shooting of Garner was believed to be linked to seven bank robberies from 1998 to 2003.

He will present on the techniques he used to pull the team together to solve the case.

Detective Abbey Abbondandolo – Cold Justice – TIPS

For ten years Cold Justice has been one of the top true-crime shows with an impressive number of arrests and convictions. As of July 2021, the team has helped to generate 49 arrests and 21 convictions, in addition to four confessions, three guilty pleas and three murder convictions. This session will go over how a team of detectives looks at a cold se and how they conduct an intense investigation over a short period of time aiding local law enforcement. Detective Abbey Abbondandolo spent 21 years in Houston Homicide is retired

from the force and currently serves as a Security Director for St. Luke's Health System in The Pacific Northwest. He was recently appointed by Texas Governor Abbott to review the Uvalde School Shooting.

Detective's Crain and Quintanilla from the Harris County Sheriff's Office – Homicide Division will present multiple investigations on Capital Murders, Murders, and Officer-involved shootings with particular emphasis on investigative methods, case preparation, and the importance of relationshipbuilding amongst agencies across the state/country. The cases to be reviewed

The Capital Murder of a 4-year-old who, along with her family members, were all shot by a group of suspects committing serial aggravated robberies; The murder of a transient female (meth addict) who willingly went with the suspect and was later found deceased in another jurisdiction;

The Capital Murder of a mother and her friend, both of whom were being stalked by her estranged husband;

The Capital Murder of a homeowner during residential burglary (following the

Fed-Ex);

The Capital Murder of an infant by the care-giving boyfriend of the mother; Car-jacking and Kidnapping / Capital Murder of female by MS-13 gang members; Case studies of numerous Officer-involved shootings by LEOs in Harris County

Richard G. Duggan – Denton County District Attorney's Office Investigating a Cold Case – The Murder of Phillip Washington

Phillip Washington, aged 50, was an ex Dallas Constable and at the time of the murder a private security guard working for several night clubs, delivering the

nightly cash deposits to the bank. Some nights he worked with a partner. This night he worked alone. It would be his last.

In the early morning hours of January 6, 2008, three masked men ambushed and shot Phillip Washington dead at a bank night deposit box in North Dallas. The suspects made off with over \$100,000 in cash, and then vanished, one of them in the victim's pickup truck. The initial investigation produced no suspects and the case soon turned cold. Over two years later a phone call changed everything.

Detective Jason White – Tulsa Police Department – Homicide Division No Body Investigation and Prosecution

Detective White is a 24-year veteran of the Tulsa Police Department with the last thirteen years in the Homicide Division. Detective White had been featured on the television series The First 48, and had instructed courses throughout the United States and Canada.

Detective White will present a review of homicide cases that involve "no-body" investigations and the subsequent prosecution of those cases. These cases will provide insight into the investigative strategies used including a look at the crime scene to developing a working rapport with the prosecution team.

Lt. Sean Migues – Galveston Police Department Underwater Homicide Scenes

This session will go over the underwater recovery process and will outline the investigative process, composition of the underwater recovery team, and the search. The strategy used by underwater search teams involves the temporal and geographical plotting of evidence, and using a grid system. How to preserve evidence such as automobiles, lights, filaments, firearms, vessels, ignitors, and explosives. The

session will deal with medicolegal aspects of underwater death, the use of recovered evidence in the courtroom, and future directions for underwater investigation. Lt. Migues will use several case studies to highlight the teaching points.
