County Judge, Christopher Boedeker welcomed everyone and thanked them for coming. He noted for Court Record that all Members of the Court were present, except for Comm. Bailey, Pct. #1. Judge Boedeker opened the Court to those who wished to comment, noting the first person to speak would be former County Judge, Roger Harmon.
