## ORDER RE-APPOINTING PURCHASING AGENT

On the 16<sup>TH</sup> of February, 2023, the undersigned District Judges of the 18<sup>th</sup> and 249<sup>th</sup> Judicial Districts, which Districts include Johnson and Somervell Counties, and the District Judge of the 413<sup>th</sup> Judicial District, which District includes Johnson County, and the Johnson County Judge, in compliance with Local Government Code Section 262.011, hereby re-appoint RALPH MCBROOM as Purchasing Agent for Johnson County for the biennial term beginning March 27, 2023 and ending March 26, 2025.

It is further Ordered that his annual salary shall be in the amount of \$109,257.00 per year, payable in equal bi-weekly installments. It is further Ordered that he shall be paid additional compensation of \$6,743.00 annually for travel allowance. The travel allowance shall be paid in equal semimonthly installments. It is further Ordered that his salary and travel allowance shall be reviewed for budgeted increases in the same manner as in other departments.

It is further Ordered that this action shall be recorded in the minutes of the District Court of Johnson County, Texas, and the District Clerk of Johnson County, Texas is hereby directed to certify the same to the Commissioners Court of Johnson County, Texas and said Commissioners Court shall cause the same to be recorded in its minutes.
