RENEWAL OF AGREEMENT FOR MAINTENANCE AND OPERATION OF THE MARKET SQUARE PROPERTY BETWEEN JOHNSON COUNTY, TEXAS AND THE CITY OF CLEBURNE

STATE OF TEXAS § KNOW ALL MEN BY THESE PRESENTS COUNTY OF JOHNSON §

WHEREAS, Johnson County, Texas and the City of Cleburne (the "Parties") entered into an agreement titled Agreement for Maintenance and Operation of the Market Square Property Between Johnson County, Texas and the City of Cleburne (the "Agreement") signed by Johnson County on March 25, 2013 and by the City of Cleburne on April 1, 2013; and

WHEREAS, the Agreement placed the maintenance and operation of property owned by Johnson County known as Market Square to be under the supervision and control of the City of Cleburne; and

WHEREAS, the term of the Agreement was for a period of ten (10) years with the option to renew the Agreement by mutual agreement of the Parties for an additional ten (10) year term; and

WHEREAS, the Parties desire to renew the Agreement for an additional ten (10) year term under the same terms and conditions.

THEREFORE, the parties agree to renew the Agreement for a ten (10) year term under the same terms and conditions as set forth in the Agreement with the effective date to be considered the date of the last party to execute this Renewal of Agreement for Maintenance and Operation of the Market Square Property Between Johnson County, Texas and the City of Cleburne (the "Renewal").

By his or her signature below, each signatory individual certifies that he or she is the properly authorized agent or officer of the applicable Party hereto and has the requisite authority necessary to execute this Renewal on behalf of such Party, and each Party hereby certifies to the other that any resolutions necessary to create such authority have been duly passed and are now in force and effect.
