

COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE MEDICAL SERVICES PROVIDED BY ONCOLOGY HEMATOLOGY CONSULTANTS, PA DBA THE CENTER FOR CANCER AND **BLOOD DISORDER ARE PROFESSIONAL SERVICES**

The Johnson County Commissioners Court met on APRIL 24, 2023 in regular session for the consideration of a contract between Johnson County, Texas and Oncology Hematology Consultants, PA dba The Center for Cancer and Blood Disorder.
