**MEMORANDUM OF DONATION OF RECLAIM MATERIAL FROM JR WEST

**KNOW ALL MEN BY THESE PRESENTS:**

Comes now **JR WEST TEXAS CONCRETE** hereafter known as Donor and Johnson County, Texas, hereafter known as Johnson County.

Whereas Johnson County is a political subdivision of the State of Texas which maintains certain roads and performs other governmental functions within Johnson County; and

Whereas Johnson County has limited resources for such maintenance; and

Whereas certain businesses and/or individuals seek to maintain and improve Johnson County through donation or transfer of certain types of property; and

Whereas Johnson County is authorized to act and does act by and through the Commissioners Court of Johnson County, pursuant to V.T.C. A., Local Government Code Section 81.032 and / or V.T.C.A., Transportation Code Section 252.214 to accept donations of property or funds.

**THEREFORE:**

Donor does hereby donate and transfer to Johnson County the materials and/or funds described below:

**Multiple truck loads of "Reclaim" generated from work performed by JR WEST TEXAS CONCRETE, LLC.**

It is the expectation of the Donor that the materials and/or funds donated to Johnson County will be used for the repair, maintenance and upgrade of roads or facilities in Johnson County, however, Johnson County makes no specific guarantee or warranty for the use of the materials donated.

Materials and/or funds donated are not subject to return to the Donor by Johnson County.

For a donation to be accepted, such donation, subsequent to being offered, must be accepted and approved by the Commissioners Court of Johnson County in an open session of the Commissioners Court of Johnson County.

Donated funds shall be paid to the County for disbursement pursuant to any conditions delineated or approved by the Commissioners Court.
