# MEMORANDUM OF DONATION OF RECLAIM MATERIAL FROM JR WEST TEXAS CONCRETE, LLC

### KNOW ALL MEN BY THESE PRESENTS:

Comes now <u>JR WEST TEXAS CONCRETE</u> hereafter known as Donor and Johnson County, Texas, hereafter known as Johnson County.

Whereas Johnson County is a political subdivision of the Sate of Texas which maintains certain roads and performs other governmental functions within Johnson County; and

Whereas Johnson County has limited resources for such maintenance; and

Whereas certain businesses and/or individuals seek to maintain and improve Johnson County through donation or transfer of certain types of property: and

Whereas Johnson County is authorized to act and does act by and through the Commissioners Court of Johnson County, pursuant to V.T.C. A., Local Government Code Section 81.032 and / or V.T.C.A., Transportation Code Section 252.214 to accept donations of property or funds.

### THEREFORE:

Donor does hereby donate and transfer to Johnson County the materials and/or funds described below:

Donated funds shall be paid to the County for disbursement pursuant to any conditions delineated or approved by the Commissioners Court.
