#### **CALL TO ORDER**

**BE IT KNOWN** that on the 22<sup>nd</sup> day of May 2023, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present. The following items, having been lawfully posted and filed for record in the Office of the County Clerk on March 18, 2023, at 1:28 P.M., were considered:

#### **PUBLIC ANNOUNCEMENTS**

**PA1.** Announcements from County Commissioners Regarding County and Precinct Events

Comm. Bailey announced that the Tire Collection Event in Pct. 1, was a success with 7,000 tires collected. He thanked the Sheriff for allowing inmates to participate and Precinct Maintenance Barn employees for giving up their Saturday to help. He updated the Court on the bills in Legislation.

Comm. Woolley expressed his appreciation to Julie Wenchell for her efforts in procuring grant funds for the Tire Collection Event.

Comm. White agreed the Tire Collection Event was a tremendous success, and that he had to close his doors at 12:00 P.M. because of the number of tires received.

Comm. Howell also expressed his thanks to the Sheriff.

Commissioner Woolley stepped out of the Meeting at 9:04 A.M. and returned at 9:04 A.M.

PA2. Presentation of Proclamation for "Johnson County Memorial & Remembrance Day Johnson County Poppy Days"

Judge Boedeker read the Proclamation for "Johnson County Memorial & Remembrance Day" and "Johnson County Poppy Day". He, along with the other Members of the Court, presented the Proclamation to Marty Peters, Member of the American Legion Auxiliary.

**PA3.** Flood Awareness Week by Jennifer VanderLaan, Public Works Director

Public Works Director, Jennifer VanderLaan stated that the Government has proclaimed May 22<sup>nd</sup> through May 26<sup>th</sup> Flood Awareness Week. She added that any questions should be directed to her at the Public Works Department.

Comm. Bailey commented that there might be difficulty with flooding due to all the growth the last few years in Johnson County.

Comm. White stated his first year in office, he saw a road that he had never seen flooded in 20 years covered in water and agreed with the growth it would be a never-ending battle.

**PA4.** Presentation by American Medical Response (AMR) to Provide Contract Status Report on Paramedic Care and Ambulance Services

Vernon Wickliffe, Operation Manager with AMR gave a presentation to the Court.

Comm. Woolley pointed out that two-thirds of the Mutual Aid are centralized in the Keene Fire Department. He stated that they are not a part of the contract, but Johnson County spends a large resource assisting them.

Comm. Bailey asked Mr. Wickliffe if he was familiar with the program at Rio Vista schools with Telehealth. He added that he thought it would be wise for him to go speak with the Superintendent at the school as he believes it would be beneficial.

Carolyn Townsend, Clinical Education Manager with AMR presented the clinical material of the presentation.

**PA5.** Update on the Status of the Construction/Renovation of County Buildings by Joshua Green, Facilities Management Director

Facilities Management Director, Josh Green gave a status update on the 911 Center and the Guinn Justice Center. He also noted that the Master Gardeners have reached out about finding a contractor to remove the dead part of the pecan tree blocking the walkway across the street from the Guinn.

Comm. Bailey commented that Judge Bosworth would be happy to get the carpet project done in the Guinn Justice Center. He also suggested getting a professional tree service involved with the tree removal so no one gets injured.
