TEXAS TRANSPORTATION CODE SECTION 601.123**


I, Peter Yorke Wrench, the undersigned Applicant, deposited Fifty-Five Thousand Dollars (\$55,000.00) with Johnson County on or about July 20, 2021 in accordance with Texas Transportation Code § 601.123. Pursuant to that Section, Johnson County issued to me evidence of financial responsibility on my vehicle. Since that time, Johnson County has retained those funds, and I have remained enrolled in the Self-Insurance Financial Responsibility Program.

I do not wish to continue participating in the Self-Insurance Financial Responsibility Program, and I request that Johnson County refund all funds belonging to me held for the purpose of that fund. I have not made any claim against the funds held by Johnson County, and I am not aware of any potential claims to be made against those funds. I am not aware of any person who may be entitled to any portion of the funds held by Johnson County other than me.

I understand that requesting a refund of these funds will withdraw me from the Self-Insurance Financial Responsibility Program, and I understand that Financial Responsibility Certificate #193 will be cancelled when this request is processed. I further understand that I must obtain alternate evidence of financial responsibility if I intend to continue driving a vehicle in the State of Texas.

I understand that I must coordinate with the Johnson County Treasurer and Johnson County Auditor to facilitate the payment of my refund, and I understand that I may be required to present valid identification prior to being issued payment. I understand that the Commissioner Court must approve the refund prior to payment being made, and I understand that I may be required to sign a receipt or other document affirming that I have received payment in full.


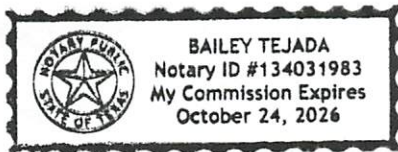
