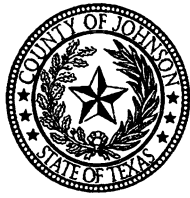

**COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE PURCHASE OF A JOHN DEERE TRACTOR WITH A SIDE MOWER FROM SCURRY COUNTY, TEXAS IS A PURCHASE FROM A POLITICAL SUBDIVISION OF THE STATE OF TEXAS**

The Johnson County Commissioners Court met on **AUGUST 14, 2023** in regular session for the consideration of a purchase of a John Deere tractor with a side mower from Scurry County, Texas, a political subdivision of the State of Texas. The Commissioners Court finds that this purchase is from a political subdivision of the State of Texas and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.




