

Dear Commissioners Court:

Pursuant to the Policy for Purchase of Firearm by Honorably Retired Peace Officer or Surviving Spouse, Child, or Parent of Deceased Peace Officer (the "Policy") please allow this letter to serve as my written approval for Tom Hargrave, retiring Chief Investigator of the County Attorney's Office, to purchase the firearm issued to him. The firearm is a SIG Sauer, Model P226, .40 Caliber, with the Serial Number of U665642 and Property Tag No. 981419. The firearm was issued to Tom when he was commissioned as a peace officer by the Sheriff of Johnson County to be a deputy sheriff. When Tom left the Johnson County Sheriff's Office to become the chief investigator for the County Attorney's Office, the firearm was transferred from being property of the Johnson County Sheriff's Office to property of the County Attorney's Office. Tom has provided me with a letter dated July 20, 2023 wherein he requests to purchase his duty weapon and I am attaching that letter to this correspondence. I am of the opinion that Tom meets all of the guidelines of the Policy and is eligible to purchase the firearm as of July 28, 2023, which is his last day of employment as Chief Investigator of the County Attorney's Office. Please have Steve Watson, County Auditor, provide the Commissioners Court with an estimate of the fair market value of the firearm.

In that letter of retirement, I stated I wanted to purchase my duty weapon as is allowed by statute, Government Code Title 6, Chapter 614, section 614.051. I was issued this weapon when I began my employment with Johnson County at the Sheriff's Office in March 2005. When I transferred my employment from the Sheriff's Office to the County Attorney's Office in August 2014, Sheriff Alford agreed to transfer the weapon to the County Attorney's Office so that I would be able to purchase the weapon upon my retirement in the future.

RE: Sale of Weapon to Retiring Officer, Tom Hargrave

Honorable Judge and Commissioners:

Section 614.051 of the Government Code states that an honorably retired peace officer may purchase the firearm that had been previously issued to him(her) for an amount not to exceed fair market value. In order for deputies, currently retiring, to proceed with the purchase of the county-issued firearm, the following price(s) are considered to be in compliance with the statute.

Sig Sauer P226. .40 S&W - \$280

The amount reflects the price range the County would likely obtain for the firearm if sold to a licensed firearms dealer.
