

ORDER REMOVING THE 3-WAY STOP SIGNS ESTABLISHED BY ORDER #2019-66 LOCATED AT 5500 CR 316, ALVARADO, TEXAS

WHEREAS, on November 12, 2019, Johnson County adopted Order #2019-66, establishing permanent three-way stop signs at the Construction Entrance/Gas Well Road at the Louis Vuitton Facility Located at the Property known as 5500 CR 316, Alvarado, Texas; and
