Main Street, Cleburne, Texas, the Commissioners Court will Conduct a Public Hearing on the Proposed Budget for the 2023 Tax Year (2024 Fiscal Year). Immediately Following the Public Hearing, the Commissioners Court will Vote on the Proposed Budget.

On September 11, 2023 at 9:00 AM in the Commissioners Courtroom, Johnson County Courthouse, 2 N. Main Street, Cleburne, Texas, the Commissioners Court will Conduct a Public Hearing on the Proposed Tax Rate for the 2023 Tax Year (2024 Fiscal Year). Immediately Following the Public Hearing, the Commissioners Court will Vote on the Tax Rate.
