**ESTABLISH A SPEED LIMIT OF 25 MPH WITHIN THE RUSTIC MEADOWS  
 SUBDIVISION THAT CONTAINS: BROOKCREST STREET, CREEKSIDE LANE,  
 RHODEN AVENUE, RUSTIC EDGE STREET, AND TRENTON WAY  
 LOCATED IN JOHNSON COUNTY, TEXAS-PRECINCT 1**

The Johnson County Commissioners Court met on November 13, 2023 in regular session and held a public hearing to consider “Establish a Speed Limit of 25 MPH within the Rustic Meadows Subdivision that contains: Brookcrest Street, Creekside Lane, Rhoden Avenue, Rustic Edge Street, and Trenton Way located in Johnson County, Texas-Precinct 1.”

The Public Hearing was properly published in the Cleburne Times Review on October 28, 2023, on the County website, and on the bulletin board of the Johnson County Commissioners Court at the Johnson County Courthouse on October 27, 2023.


**A motion was made by Commissioner Bailey, Pct. 1 and seconded by Commissioner Howell, Pct. 2 to approve “Establish a Speed Limit of 25 MPH within the Rustic Meadows Subdivision that contains: Brookcrest Street, Creekside Lane, Rhoden Avenue, Rustic Edge Street, and Trenton Way located in Johnson County, Texas-Precinct 1.”**


