## ORDER AUTHORIZING COUNTY ATTORNEY TO FILE LAWSUIT AND AUTHORIZING EXPENSES

On this the 13<sup>th</sup> day of November, 2023, the Commissioners Court of Johnson County, being duly convened at a regularly called meeting of the Commissioners Court, upon motion of Commissioner White, Pct. 3, seconded by Commissioner Howell, Pct. 2, duly put and carried, adopted the following:

1.

Whereas, Johnson County, Texas is a political subdivision of the State of Texas, and through its Commissioners Court has the authority to bring suit to enforce the statutes enacted by the Texas Legislature that affect Johnson County; and

2.

Whereas, Chapter 251 of the Texas Transportation Code provides general county authority relating to roads and bridges in a county; and

3.

Whereas, there exists in Johnson County a public road, namely, CR 603C, that an individual or individuals have placed fencing and gates across said road; and

Whereas, the Commissioners Court of Johnson County has not entered any orders to abandon, vacate or close said CR 603C; and

5.

Whereas, even though Precinct #3 Commissioner does not maintain CR 603C, CR 603C has not lost its character as a public road and remains a public road of Johnson County, Texas; and

6.

Whereas, the fencing and gates across CR 603C are restricting ingress and egress to property owners who own real property adjacent to CR 603C and additionally restricts the travel of anyone who wants to travel CR 603C.

7.

IT IS THEREFORE ORDERED that the County Attorney of Johnson County, Texas is hereby authorized to file a lawsuit for a declaratory judgment declaring that CR 603C is a public road and for a permanent injunction against the person or persons who have installed fencing and gates across CR 603C in Johnson County, Texas to remove said fencing and gates in the right-of-way of CR 603C.

8.

IT IS FURTHER ORDERED that the County Attorney is authorized to expend the amount of \$4,000.00 as initial expenses in the case, which amount includes, but is not limited to, funds for court reporter fees, expert fees and expenses, discovery costs, and any other reasonable and necessary expenses.

All funds necessary to accomplish the above are hereby ordered to be made.

10.

All such costs and fees should be charged to the general fund.
