# MINUTES OF THE JOHNSON COUNTY JUVENILE BOARD MEETING FOR NOVEMBER 15, 2023

The Johnson County Juvenile Board met November 15, 2023, at 12:00 noon, in the jury room of the County Court at Law No. 2, Fourth Floor, Guinn Justice Center, pursuant to required notice.

The following board members were present: Judge William Bosworth, Judge Sydney Hewlett, Judge Steve McClure, Judge Tiffany Strother, Judge Chris Boedeker. Also present was County Attorney, Bill Moore; County Auditor, Steve Watson; Director of Juvenile Services, Jeremy Burrell; Auditor's Office Representative Barbara Abdalla..

- 1. INVOCATION:
  - Judge McClure gave the invocation.
- 2. APPROVAL OF MINUTES FOR AUGUST 29, 2023.

A motion was made by Judge McClure and seconded by Judge Boedeker to approve the Minutes as printed. Motion carried.

3. DISCUSSION AND TAKE ANY APPROPRIATE ACTION REGARDING THE DISBURSEMENT OF THE FY24 STATE SALARY ADJUSTMENT GRANT IN THE AMOUNT OF \$34.849.10.

Mr. Burrell explained it was previously authorized to accept the grant money and a decision needed to be made on its disbursement. He suggested disbursing it in the form of certification pay or supplemental pay over the remaining pay periods of the State fiscal year. Mr. Burrell explained it wouldn't impact the County for funding if the State fails to fund beyond year two and that a clause be added that the officers be informed that if the State funding goes away so does the certification pay. The Auditor's Office expressed needing clarification from the State regarding the grant amount and pay amount.

A motion was made by Judge Boedeker and seconded by Judge Neill for the County to accept the disbursement of the fiscal year state salary adjustment grant of \$34,849.10, contingent on the Auditor getting clarification about the grant amount and pay amount.
