Here is some quick information on the upcoming general election in May:

- General Election: Saturday, May 4, 2024.
- Early Voting dates: April 22 April 30, 2024

Possibly three (3) elections will occur (1) City of Burleson council election, (2) BISD board of trustees election; and (3) Possible Local Option election:

- City Council places on the ballot:
 - o Council, Place 1
 - Council, Place 3
 - o Council, Place 5
- BISD Board of Trustees on the ballot:
 - o Place 5

- o Place 6
- o Place 7
- Possible Local Option Election to legalize the legal sale of all alcoholic beverages for offpremise consumption only.

BISD contracts with the city to run their election for them, so the City of Burleson will conduct possibly three (3) elections (2 general and 1 special). We will hire all poll workers and security for early voting and election day. We will also provide all voting equipment and ballots.
