Judge Boedeker,

Here is some quick information on the upcoming general election in May:

- General Election: Saturday, May 4, 2024.
- Early Voting dates: April 22 – April 30, 2024

Possibly three (3) elections will occur (1) City of Burleson council election, (2) BISD board of trustees election; and (3) Possible Local Option election:

- City Council places on the ballot:
 - Council, Place 1
 - Council, Place 3
 - Council, Place 5
- BISD Board of Trustees on the ballot:
 - Place 5

- Place 6
- Place 7
- Possible Local Option Election to legalize the legal sale of all alcoholic beverages for off-premise consumption only.

BISD contracts with the city to run their election for them, so the City of Burleson will conduct possibly three (3) elections (2 general and 1 special). We will hire all poll workers and security for early voting and election day. We will also provide all voting equipment and ballots.
