**COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, TEX. LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, TEX. LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT ROAD AND BRIDGE EQUIPMENT AND/OR VEHICLES SOLD BY RITCHIE BROTHERS AUCTIONS IS PERSONAL PROPERTY SOLD AT AN AUCTION BY A STATE LICENSED AUCTIONEER**

The Johnson County Commissioners Court met on **January 8, 2024** in regular session for the consideration of a purchase of road and bridge equipment and/or vehicles by Johnson County, Texas from Ritchie Brothers Auctions. The Commissioners Court finds that this purchase is to be made at an auction by a state licensed auctioneer and that the Commissioners Court may grant an exemption under Section 262.024, Tex. Local Government Code, from the competitive bidding requirements of Section 262.023, Tex. Local Government Code.


**A motion was made by Commissioner Bailey, Pct. 1 and seconded by Commissioner Howell, Pct. 2 that:** "The Commissioners Court finds the purchase of road and bridge equipment and/or vehicles by Johnson County, Texas from Ritchie Brothers Auctions is the purchase of personal property to be made at an auction by a state licensed auctioneer and that the Commissioners Court grants an exemption under Section 262.024, Tex. Local Government Code, from the competitive bidding requirements of Section 262.023, Tex. Local Government Code, and enter an Order to that effect and approve the purchase in an amount not to exceed \$200,000.00."

Said motion was approved by a vote of the Commissioners Court on the **8<sup>TH</sup> DAY OF JANUARY, 2024.**

**NOW THEREFORE BE IT RESOLVED AND ORDERED:**

The Commissioners Court of Johnson County, Texas does hereby enter this Order granting an exemption under Section 262.024, Tex. Local Government Code, from the bidding requirements of Section 262.023, Tex. Local Government Code, upon the Commissioners Court finding that the purchase of road and bridge equipment and/or vehicles by Johnson County, Texas from Ritchie Brothers Auctions is the purchase of personal property to be made at an auction by a state licensed auctioneer and that the Commissioners Court grants an exemption under Section 262.024, Tex. Local Government Code, from the competitive bidding requirements of Section 262.023, Tex. Local Government Code, and enter an Order to that effect and approve the purchase in an amount not to exceed \$200,000.00.




