CONSTABLE PRECINCT 1 has adopted a detailed written policy on racial profiling. Our policy:

- 1) clearly defines acts constituting racial profiling;
- 2) strictly prohibits peace officers employed by the CONSTABLE PRECINCT 1 from engaging in racial profiling;
- 3) implements a process by which an individual may file a complaint with the CONSTABLE PRECINCT 1 if the individual believes that a peace officer employed by the CONSTABLE PRECINCT 1 has engaged in racial profiling with respect to the individual;
- 4) provides public education relating to the agency's complaint process;
- 5) requires appropriate corrective action to be taken against a peace officer employed by the CONSTABLE PRECINCT 1 who, after an investigation, is shown to have engaged in racial profiling in violation of the CONSTABLE PRECINCT 1 policy;
- 6) requires collection of information relating to motor vehicle stops in which a citation is issued and to arrests made as a result of those stops, including information relating to:
 - a. the race or ethnicity of the individual detained;
 - b. whether a search was conducted and, if so, whether the individual detained consented to the search;
