Dear Mr. Porter,

Summary

In accordance with Local Government Code, Section 115, the Auditor's Office performed a review of the Ad Valorem account files, for the 2022 fiscal year. To accomplish the audit, we reviewed the SpindleMedia Tax Office 4 software reports and the Central Appraisal District of Johnson County (CAD) certified role files.

Background

The Tax Assessor-Collector assesses and collects ad valorem taxes for Johnson County and other taxing entities. Once the tax rates are set, the property tax statements are sent out yearly, in October. Additionally, the Tax Office is tasked with collecting various taxes and fees related to motor vehicles, trailers, boats, beer and wine as well as liquor.

Scope

The Tax Office Ad Valorem utilizes SpindleMedia Tax Office 4 software, and the Central Appraisal District of Johnson County (CAD) certified role files. We compared these files to ensure the tax rates and discounts were properly recorded., utilizing Caseware IDEA-Data Analysis Software (IDEA).

Objective

To accomplish this audit, we examined a random sample of properties from the CAD report file and compared it to the SpindleMedia Tax Office 4 software reports for this period. We also utilized Caseware IDEA-Data Analysis Software (IDEA), to create a random selection of property accounts and tested them for accuracy.

Findings

There were no exceptions that would lead us to conclude that the property taxes charged and collected, for this period were not, in all material respects, appropriately charged, and reported.
