- 4. The applicant specifically agrees that if credit availability is extended to the applicant, Ben E. Keith Company reserves the right at any time to suspend, terminate or alter credit availability and terms, in whole or part, when in its opinion the financial condition or business practices of the applicant warrants. In such case, in addition to any other remedies, cash payment or satisfactory security may be required before shipment or delivery. Any failure to pay an invoice when due makes the unpaid amount of all outstanding invoices immediately due and payable irrespective of their terms should Ben E. Keith Company so elect and Ben E. Keith Company may withhold all deliveries until the full amount due under such invoices is settled. Acceptance by Ben E.
