ORDER APPOINTING INAUGURAL FIRE MARSHAL, JAMIE R. MOORE TO A TERM BEGINNING MARCH 25, 2024 AND ENDING MARCH 24, 2026

WHEREAS, Johnson County is the 26th most populous county in the State of Texas with an estimated population of 197,638 as of January 1, 2023, according to the Texas Demographic Center; and

WHEREAS, Johnson County, in recognition of its status as a large, fast-growing, increasingly-urban county, determined that the creation of a Fire Marshal's Office would serve the citizens of Johnson County; and

WHEREAS, the Texas Commission on Law Enforcement has authorized Johnson County to create the Office of the Johnson County Fire Marshal; and

WHEREAS, under Subchapter B of Chapter 352 of the Texas Local Government Code. the Commissioners Court has the authority to appoint the Johnson County Fire Marshal; and

WHEREAS, Jamie R. Moore has distinguished himself by serving as the Emergency Management Coordinator for Johnson County for 11 years, serving as a reserve deputy for the Johnson County Sheriff's Office, and demonstrating his competence in all areas related to fire prevention, education, and investigation.

NOW THEREFORE BE IT ORDERED that Johnson County does hereby appoint

JAMIE R. MOORE AS THE JOHNSON COUNTY FIRE MARSHAL

for a term beginning on March 25, 2024 and ending on March 24, 2026.

AND BE IT FURTHER REMEMBERED that Johnson County hereby officially, and publicly, expresses its gratitude and appreciation to Jamie R. Moore for his diligent service to Johnson County and for the long hours dedicated to the creation of this Office.


